## Mandatory visa conditions:

- 1. Visa issuing authority for the first visa including 'No Visa Required (NVR)' is generally Bangladesh Missions abroad. Conversion of a visa category (from VoA to A2, E1, E2, E3, PI) and first visa in converted category will be approved by the Security Services Division (SSD). Extension of visa in the same category and allowing exit permit will be executed by the Security Services Division/ Department of Immigration and Passports (DIP). Immigration authority of designated entry port will grant Visa on Arrival/Transit visa. Concerned offices may seek direction from the SSD prior to issuing visa if necessary. The Security Services Division retains full authority in any matter relating to visa and immigration.
- 2. Concerned visa issuing authority will grant visa on its own responsibility after being satisfied on examining the relevant documents and keeping records in writing. A visa issuing authority may refer to the Security Services Division for necessary approval, if necessary.
- 3. Visa will be granted on the basis of relevant visa notifications. In cases of bilateral agreements and arrangements with other countries visa will be issued according to the agreements/arrangements. Principal of reciprocity is to be followed for issues that are not covered in visa circular and agreement/ arrangement.
- 4. For A2 categories of visa, United Nations and its organizations means WHO, UNDP, FAO, UNFPA, ILO ,UNICEF ,UNESCO ,IMF ,World Bank ,WFP, IDB, UNCTAD, UNHCR, IOM, UNODC etc. International and Regional organization means USAID, JICA, JBIC, DFID, CIDA, SIDA, DANIDA, Peace Corps, NORAD, FINNIDA, ICDDRB, ADB, Red Cross/Red Crescent, BIMSTEC, SAARC, Commonwealth, IFAD, OIC and other organizations of similar type.
- 5. Machine Readable Visa (MRV) must be issued in all cases. In case of any emergency situation different method can be prescribed by the Security Services Division. When computer programme based/ electronically issued visa (e visa) system will be in force, visa number has to be mentioned according to programme code.
- 6. Visa issuing authorities have to mention following conditions on the visa label while issuing visas:
  - (A) For categories of A1, FA2, B, C, FE1, FE2, FE3, M, FM, FJ, R, FR, FP, FN, FPI, S, RH, FSR, T, RT and FBN with "Employment in Bangladesh prohibited".
  - (B) At the time of issuing E1, E2, PI and N1 category visa, passport of a person arriving with a view to take up employment /work must be stamped with the condition "Please apply for work permit to BIDA/BEPZA/BEZA/ High-Tech Park/NGO Affairs Bureau/PPPAB and other competent authorities within 15(fifteen) days of first entry into Bangladesh".
- 7. A person arriving from India and Pakistan with a visa for 90(ninety) days or more has to register with the immigration authorities at the airport/land port within 14(fourteen) days of arrival.
- 8. Foreign nationals arriving from countries other than India and Pakistan will be exempted from such requirement.

- 9. Application for an extension of visa has to be made at least 01(one) month before the expiry of the visa. If application is lodged after the expiry date, penalty shall be applicable on ground of overstay.
- 10. A visa category will not be converted after entering into Bangladesh other than Visa on Arrival (VoA). VoA can be converted only into A2, E1, E2, E3 and PI category. Additional fee for the change of category equivalent to US \$ 100.00 per visa will be applicable except for PI category. UN passport holders will not be charged for visa conversion.
- 11. Valid visa of an old passport can be transferred to a new passport upon application with payment of fees equivalent to US\$ 50.00.
- 12. In case a report is required for issue and extension of a visa, the concerned agency—shall provide the report within 15 (fifteen) working days of receiving request from the visa authority. If no report is received within the time specified, visa issuing authority may take appropriate decision taking into consideration that the said agency has no objection on granting or extending the visa. No such opinion from the agency shall be required for a children under 15 (fifteen) years of age.
- 13. For the civil and military officials from overseas arriving for specific work and training in the defense service institutions in Bangladesh, the recommendations of Armed Forces Division(AFD) will be accepted in lieu of the work permit and security clearance. Bangladesh Missions may grant visa with multiple entry to those persons and their dependents for additional 1(one) month along with the full tenure of training / work in line with the recommendation from the Armed Forces Division.
- 14. If any foreign national arriving with the objective of employment or investment or business or education purposes, conceals any information or violates any condition of the visa issued, the appointing/ recommending/sponsoring organization of that person shall be fined TK 20,000/- (twenty thousand) per person for the first time and TK 1,00,000/- (one lac) for similar and any subsequent violation.
- 15. No visa will be granted to a foreign student willing to study at the religious institutions which are not approved by the Government of Bangladesh.
- 16. If a citizen of any country other than a visa prohibited country desires to visit Bangladesh for tourism from a third country, Bangladesh Mission in that particular country after being satisfied, may grant 'T' category visa in favour of the applicant.
- 18. Visa fees shall not be refunded if a visa application is declined.
- 19. A person arriving from a country which has been declared as public health emergency of international concerned by WHO may be required to undergo health screening or additional measures as decided by the competent authority at the designated entry port from time to time.
- 20. A visa is to be issued upon considering individual application on case to case basis after careful examination of documents and on being fully satisfied about the purpose of the visit.
- 21. A2, E1, E2, E3, S, RH, PI, FBN visas may be issued with maximum duration for the respective category.

- 22. For other categories, visa can be granted for any duration up to the maximum approved duration for that specific category considering individual requirements.
- 23. If a visa is not granted up to its maximum period, then an application for extension of that particular visa is to be responded as per the instructions of extension of that category of visa rather than considering it as a case of first visa.
- 24. Security Services Division/Department of immigration may issue exit permit after realization of fine for overstay. Police report may be taken where required.
- 25. For granting or extension of visa, security clearance means clearance issued by the SSD. Police report will imply report from Special Branch of Police.
- 26. With regard to the conversion and extension of a visa more than the maximum period allowed in the circular, the Security Services Division may waive, impose or relax any condition mentioned in the circular.
- 27. Instructions of the Security Services Division shall be final in case of any explanation/clarification/guidance on the issued circulars where required.
- 28. The new circular will be in force on the 181<sup>st</sup> day from the date of issue of this and all circulars previously issued concerning this shall be deemed to have been replaced from the 181<sup>st</sup> day. The current visa circulars will remain valid meantime and all issued visas will also remain valid until expiry. Granting any new visa, extension, change of category, imposition and realization of fine for overstay etc. will commence as per the new circular from the 181st day. Ministry of Foreign Affairs and Bangladesh Missions abroad shall ensure publicity of the new circulars and the Department of Immigration and Passports shall ensure publicity within Bangladesh.
